RATIONALE: The rationale of this meeting is based on some goals: 1.Avoiding irreproducibility of clinical research. 2.Accelerating biomarker validation to give to Oncology Excellence Centres more opportunities to have better prognosis and treatment for patients. 3.Improving the use clinical tissues on the European level. 4.Pointing out that today clinical research is completely integrated with practical medical application.

Accreditation of Comprehensive Cancer Centres by OECI, improvement of the biobanking organization in Europe for Archive Tissues by the Biobanking European Infrastructures (BBMRI-ERIC), standardization of analysis methods by the Working Groups of the European Society of Pathology (ESP), improvement of preanalytical conditions of tissues by CEN, and handling of tumour heterogeneity are all activities that have been developed in Europe in the past years to reach these goals.
